Sequence of Admission Activities:

- The candidates, on arrival at the Department of Law, FSSS (Room No EAC-809), must collect Admission Form and Bank's Deposit Slip for admission fee payment. Upon receiving the copy of Admission Form, Bank's Deposit Slip for admission fee payment and other necessary forms from Program office, candidates are requested to fill up them and deposit Taka 54,700 (Tk Fifty Four Thousand and Seven Hundreds only)¹ in favour of "LLM Professional Program" A/C Number 0106-0310040062, Trust Bank Ltd., Mirpur Cantonment Branch. They must collect receipt from Program Office Room (EAC-809) as they will have to deposit the same for completion of admission formalities.

¹ The following next two trimesters' fee will be 42,900/- and 42,400/- respectively.

3. Candidates must bring the following **original documents** and **two full set of photocopies (with attested)** along with them:
- a. Certificate and Transcript of SSC/ O Level or equivalent examination
 - b. Certificate and Transcript of HSC/ A Level or equivalent examination.
 - c. Certificate and Transcript of Bachelor of Laws (LLB- Hons).
 - d. Equivalent Certificate for Foreign degrees holder Given by Competent Authority (e.g. Bangladesh Bar Council/ UGC/ Education Board).
 - e. Photocopy of National ID Card attested.
 - f. 3 copies of passport size colored photograph duly attested.
4. The candidates will then report to BUP Medical Centre located inside the campus, hand over the following medical documents from any reputed hospital/clinic and collect medical fitness certificate of:
- a. Blood group
 - b. Urine R/E
 - c. HBs Ag
5. Finally, the candidates will report to Department of Law, LLM Professional Program Office (Room no. EAC-809) and deposit the following documents for the completion of the admission process:
- a. Completed Admission Form
 - b. Money Deposit slip/receipt of the Bank.
 - c. All Original Certificates/ Documents as mentioned in Paragraph 2 above.
 - d. **Two full set of photocopies (with attested)** to be submitted under paragraph (3)

Commencement of Academic Session:

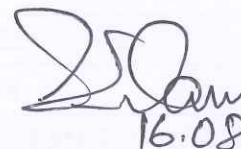
